**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Murder - 2nd Degree - With Intent-Not Premeditated**

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 09/07/2018

Control #(ICR#): 18303001

Charge Description: That on or about September 7, 2018, in Hennepin County, Minnesota, ANTHONY EDWARD CANNADY, while using a firearm, caused the death of S.F., a human being, with intent to effect the death of that person or another, but without premeditation.

Charge Description: That on or about September 7, 2018, in Hennepin County, Minnesota, ANTHONY EDWARD CANNADY, while using or possessing a firearm, assaulted Victim 4.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about September 7, 2018, at approximately 11:45 p.m., Minneapolis Police officers responded to a shooting that occurred in the parking lot of Cliff and Norms Bar located at 2024 Washington Ave. North, city of Minneapolis, Hennepin County, Minnesota.

Upon arrival, they found an adult male (S.F.) dead from an apparent gunshot wound. Victims 2, 3 and 4 also sustained non-life threatening gunshot wounds. Officers observed numerous discarded cartridge casings littering the scene. Investigators reviewed the scene, interviewed witnesses, interviewed the surviving victims and viewed surveillance video from the bar. Investigators learned the following in the course of their investigation:

On the evening of September 7, 2018 a man later positively identified as ANTHONY EDWARD CANNADY, D.O.B. 12/30/1970, Defendant herein, was at the bar. An altercation broke out between the Defendant and another bar patron. A bouncer attempted to break up the fight and the Defendant was maced in the scuffle. The Defendant became angry, made threats toward the bouncer and left the bar. The Defendant later returned and shot into a crowd in the parking lot. Victim S.F. died from an apparent gunshot wound to his head and Victims 2-4 sustained non-life threatening gunshot wounds. In the days following the incident the Defendant told numerous people that he killed someone at Cliff and Norm's that night.

Defendant is presently in custody and is a danger to public safety.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
