The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-1st Degree-Use of deadly force against peace officer/prosecutor/judge or correction employee

Minnesota Statute: 609.221.2(a), with reference to: 609.11.5, 609.101.2, 609.221.2(a), 609.221.2(b)

Maximum Sentence: 20 YEARS AND/OR \$30,000, WITH NO SUPERVISED RELEASE

Offense Level: Felony

Offense Date (on or about): 03/16/2020

Control #(ICR#): 20200189

Charge Description: That on or about 3/16/2020, in Brooklyn Park, Hennepin County, Minnesota, JAMES HOWARD KLEIN while using a dangerous weapon, a firearm, assaulted Officer A, a peace officer, by using or attempting to use deadly force against the officer while Officer A was engaged in the performance of his or her duties imposed by law, policy or rule.

Minimum Sentence: 10 YEARS

Charge: Assault-1st Degree-Use of deadly force against peace officer/prosecutor/judge or correction employee

performance of his or her duties imposed by law, policy or rule.

Minimum Sentence: 10 YEARS

COUNT III

Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence

Maximum Sentence: 15 YEARS AND/OR \$30,000

Offense Level: Felony

Charge Description: That on or about 3/16/2020, in Brooklyn Park, Hennepin County, Minnesota, JAMES HOWARD KLEIN possessed ammunition or a firearm and JAMES HOWARD KLEIN has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, Second Degree Drugs on February 15, 2013, for which the sentence or court supervision expired on or after August 1, 1993.

Minimum Sentence: 5 YEARS

STATEMENT OF PROBABLE CAUSE

Complainant, a licensed peace officer with the BCA, has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On March 16, 2020, Brooklyn Park Police Officers were dispatched to the Walmart located in Brooklyn Park, Hennepin County, Minnesota, on a shoplifting call. Officers also had information that the suspect was purchasing a large amount of ammunition and was wearing a holster.

Upon arrival in a marked squad, Officer A approached the suspect in the parking lot and asked that he stop. The suspect, later identified as JAMES HOWARD KLEIN, the defendant herein, can be seen on body camera with his hand in his coat pocket. The defendant ignored the command to stop and remove his hand from the pocket and continued to walk away from Officer A. The defendant continued to ignore Officer A's multiple orders to stop.

In order to stop the defendant, Officer A pulled out and deployed his Taser. The Taser had minimal effect on the defendant who ran away between two vehicles parked in the lot. At that time, the defendant fired a gun at Officer A. Officer A called out the shots by the defendant and then returned fire.

Another arriving officer, Officer B, engaged the defendant upon arrival. As Officer B gave chase and returned fire, he observed the defendant point a handgun at a white-colored vehicle in the lot. When the vehicle drove off, the defendant turned toward Officer B with the handgun still drawn. At that time Officer B was forced to fire again, hitting the defendant and knocking him to the ground.

As the defendant is falling, a handgun is visible, on body camera, falling to the pavement. During a search of the defendant, officers found a "bandolero" style belt around the defendant's midsection that was holding numerous rounds of additional ammunition.

The defendant was transported to the hospital to be treated for gunshot wounds to the leg and hand. No officer was hit by gunfire.

Following the incident, Officer A informed a superior officer that the defendant "pulled a gun on me out there and started shooting and I returned fire."

Defendant is ineligible to possess a firearm. The defendant has multiple prior convictions including Second Degree Drugs and Ineligible Person in Possession of a Firearm convictions from February 15, 2013.

The defendant is currently in the hospital under guard by officers. The State requests that a warrant issue for the defendant's arrest.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
